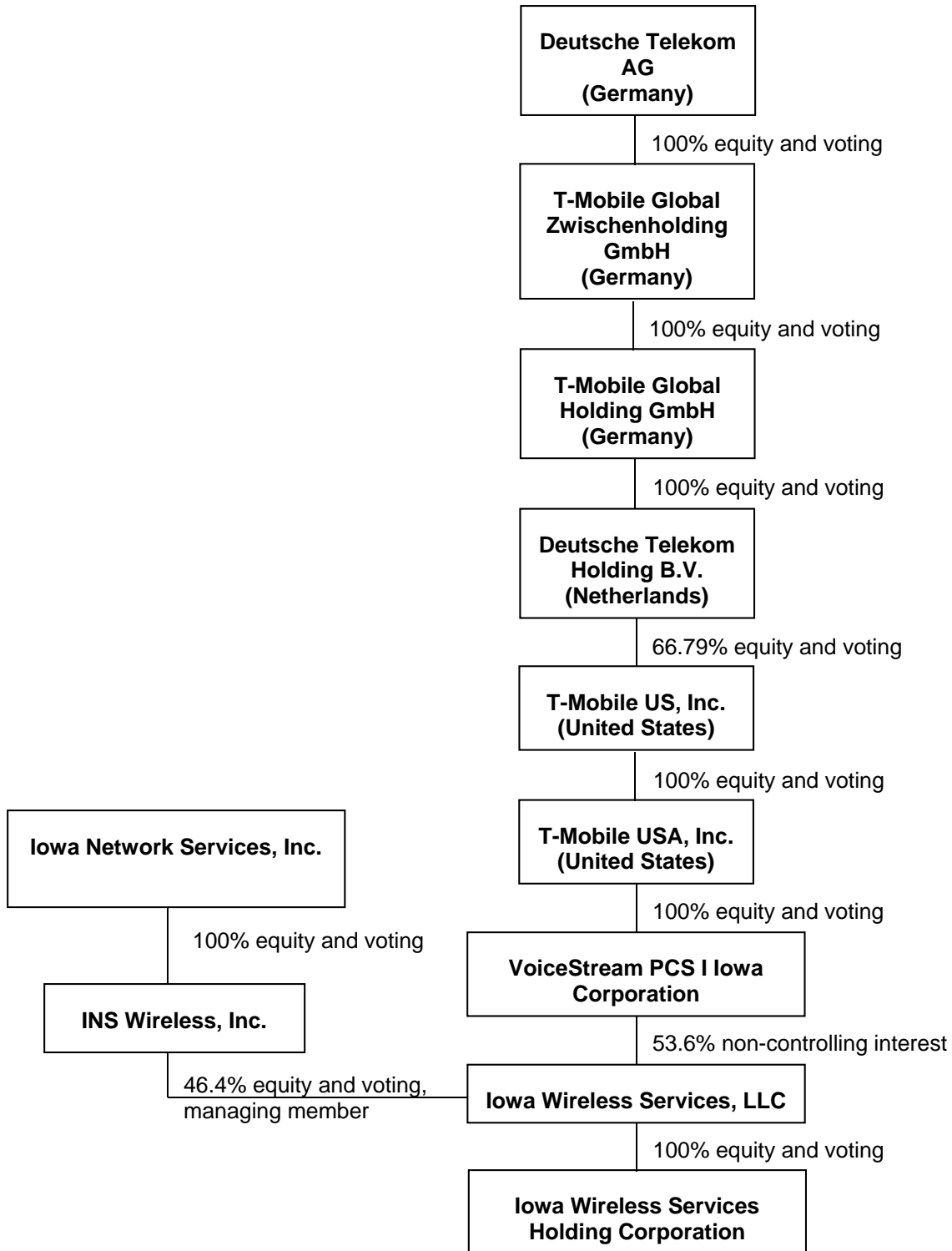

**Answer to Question 13**
