As part of LAN's acquisition of all of the assets and business of MED, LAN acquired, among other things, MED's Section 214 authorization, ITC – 214 – 20020412 – 0178.

After the consummation of the above-referenced transaction on June 30, 2010, LAN changed its legal name to LAN MED Nautilus Limited effective on July 15, 2010. LAN again changed its name to TI Sparkle Ireland Telecommunications Limited effective on November 17, 2016.

After the sale of its assets and business to LAN on June 30, 2010, MED was merged into Telecom Italia Sparkle Luxembourg SA, LAN and MED's then sole shareholder. After MED was merged into Telecom Italia Sparkle Luxembourg SA the latter was in turn merged into its sole shareholder, Telecom Italia Sparkle S.p.A.

As a result of the foregoing transactions, MED no longer exists as a legal entity and LAN presently exists under the legal name TI Sparkle Ireland Telecommunications Limited, whose current sole shareholder is Telecom Italia Sparkle S.p.A.

LAN hereby notifies the Commission of the *pro forma* assignment of the international Section 214 authorization held by MED as a result of an internal corporate restructuring of Telecom Italia Sparkle S.p.A, the sole shareholder, *inter alia*, of LAN and MED through which LAN acquired the assets and business of MED. As this transaction did not change the ultimate control of the Section 214 authorization holder, the transaction is *pro forma* in nature.
