KPN International Network Services, Inc. (“KPN INS” or “Assignor”) is listed as holding three international Section 214 authorizations: ITC-214-19970602-00298 (formerly ITC-97-301); ITC-214-19970702-00363 (formerly ITC-97-383); and ITC-214-19970702-00369 (formerly ITC-97-382).

Pursuant to Section 63.24(f) of the Commission’s rules, the Commission is hereby notified of the *pro forma* assignment of these three international Section 214 authorizations from KPN INS to its indirect 100 percent parent KPN B.V. (“Assignee”) on June 30, 2017. Because the assignment did not result in a change in the ultimate control of the international Section 214 authorizations, the assignment is classified as *pro forma*.

*B. ANSWER TO QUESTION 11 – SECTION 63.18(h)*

The proposed Assignee is 100 percent directly owned by Koninklijke KPN NV, which is a publicly-traded landline and mobile telecommunications company headquartered in the Netherlands and listed on the Euronext Amsterdam stock exchange. Koninklijke KPN NV has only one stockholder that has 10 percent or more of its shares, American Movil, S.A.B. de C.V. (“American Movil”).

Ownership interest: Because Carlos Slim Helu, his Family, and Trust (collectively, “Slim Family”) are deemed to control American Movil (the 22.1 percent owner of Koninklijke KPN NV), the Slim Family collectively may be deemed to be an indirect holder of approximately 10-15 percent of the equity of KPN B.V. Additional information on the ownership of America Movil can be found in its most recent SEC Form 20-F.<sup>1</sup> According to American Movil’s SEC Form 20-F, no other person or entity directly owns 5 percent or more of American Movil.

No other person or entity holds a direct or indirect 10-percent-or-greater voting or equity interest in Assignee KPN B.V. An ownership diagram is attached.

*C. ANSWER TO QUESTION 12 – INTERLOCKING DIRECTORATES*

The KPN family of companies has interlocking directorates among themselves. Otherwise Assignee KPN B.V. has no other interlocking directorates with a foreign carrier.

*D. ANSWER TO QUESTION 13 – NARRATIVE OF PRO FORMA ASSIGNMENT, PUBLIC INTEREST STATEMENT, AND SECTION 63.21(h) NOTIFICATION*

The assignment of the international 214 authorizations from KPN INS to its indirect 100 percent parent KPN B.V. is to simplify intercompany relations within the KPN group.

KPN INS, a U.S. corporation, hereby notifies the Commission pursuant to Section 63.21(h) of the FCC’s rules that it continues to provide international services under the international Section 214 authorizations held by its 100 percent parent KPN B.V.<sup>2</sup>
