Re: Application for Assignment of BVUA's Telecommunications Assets

Dear Ms. Dortch:

BVU Authority and Sunset Fiber, LLC ("Sunset Digital") (collectively "Applicants") hereby provide supplemental information with respect to the application to assign control of BVU's telecommunications assets, from BVU to Sunset Digital. Applicants originally filed their application with the International Bureau and the Wireline Competition Bureau on September 14, 2017. Applicants supplemented their application on September 29, 2017. In response to several information requests from staff, Applicants provide the following additional supplementation.

In Virginia, Sunset Digital's area of service includes the County of Lee, County of Wise, and County of Scott, as well as the City of Norton and City of Danville. In Tennessee, Sunset Digital's area of service includes the County of Claiborne, County of Hancock, City of Kingsport, City of Johnson City, and the County of Washington.

H.I.G. Capital Partners V, L.P. ("H.I.G. V") is a limited partnership with H.I.G. Advisors V, LLC as the general partner. Because H.I.G. V is organized as a limited partnership, it does not have a board of directors. No individual or entity directly or indirectly owns 10% or more of H.I.G. V. H.I.G. V does not have any direct or indirect interest in any entity that provides telecommunications service or holds a license to provide telecommunications service.

Similarly, H.I.G. V's general partner, H.I.G. Advisors V, LLC, does not have a board of directors. H.I.G. Advisors V, LLC's manager is H.I.G.-GP II, Inc. H.I.G.-GP II, Inc. in turn has two board members, Tony Tamer and Sami Mnaymneh.

As noted in the application, H.I.G. V is an affiliate of H.I.G. Capital, L.L.C. However, H.I.G. Capital, LLC owns less than a 0.01% equity interest in H.I.G. V.
