The present pro forma and attachment are being submitted to reflect the consummation of a merger transaction by TI Sparkle Ireland Telecommunications Limited, an Irish limited company ("TIS Ireland") with and into its sole stockholder, Telecom Italia Sparkle S.p.A., an Italian company ("TIS"), as a result of which TIS acquired all of the assets and business of its wholly-owned subsidiary TIS Ireland, effective as of July 27, 2017. As part of TIS's acquisition of all of the assets and business of TIS Ireland, TIS acquired, among other things, TIS Ireland's Section 214 authorization, ITC – 214 – 20020412 – 0178 and TIS Ireland no longer exists as a separate legal entity.

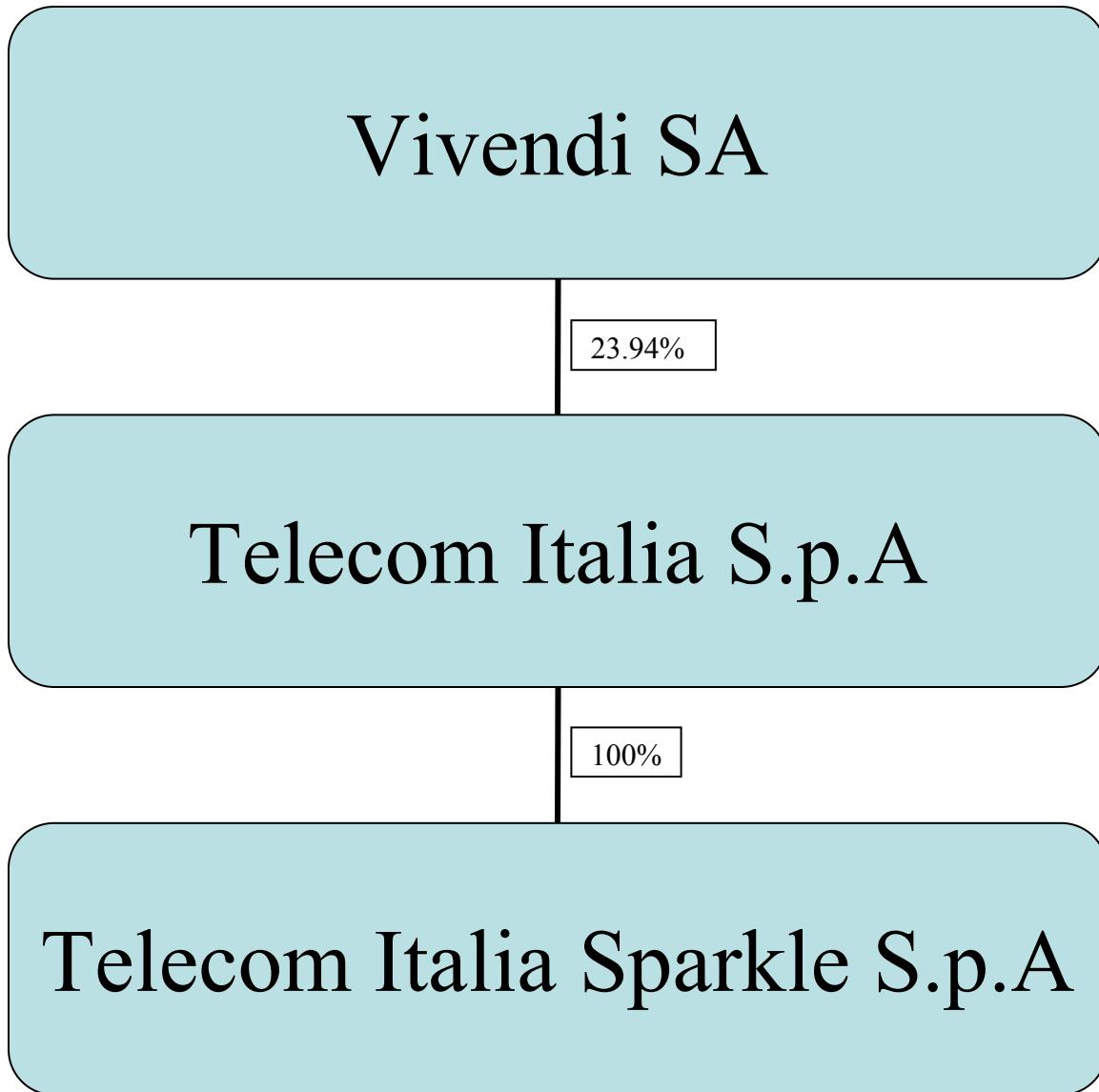

As this transaction did not change the ultimate control of the Section 214 authorization holder, the transaction is *pro forma* in nature.
