This authorization was assigned to the applicant as part of a related filing.

Question 13: Narrative


As part of a number of *pro forma* conversions made in order to clean up the organizational chart for Allstream Business US, LLC and consolidate its operating entities, the subsidiaries of Eschelon Telecom, Inc.¹ were merged into Eschelon Telecom, Inc. (ITC-214-19990729-00490) (“Eschelon”) and Eschelon was subsequently merged into Electric Lightwave, LLC (ITC-214-1994041500137). This became effective on February 2, 2018. As a result, the International 214 authorization held by Eschelon Telecom, Inc. is no longer required and can be terminated.

¹ The subsidiaries of Eschelon Telecom, Inc. were Advanced TelCom, Inc., Eschelon Telecom of Arizona, Inc., Eschelon Telecom of Colorado, Inc., Eschelon Telecom of Minnesota, Inc., Eschelon Telecom of Nevada, Inc., Eschelon Telecom of Oregon, Inc., Eschelon Telecom of Utah, Inc., Eschelon Telecom of Washington, Inc., Mountain Telecommunications of Arizona, Inc., OneEighty Communications, Inc., Shared Communications Services, Inc., and United Communications, Inc.
