


### Answer to Question 12: Interlocking Directorates of Assignee

### Answer to Question 13: Narrative Description of Transaction

The notification at issue refers to the assignment of the above-named 214 license from Assignor to Assignee as shown in the diagram below. The assignment took place by way of an Asset Purchase Agreement transaction that closed on <u>September 25, 2018</u>. The assignor does not plan to continue operating with 214 authority.



Pursuant to §63.24(d) of the Commission's rules, 47 C.F.R. §63.24(d), an assignment that does not result in a change in the actual controlling party is considered a non-substantial or *pro-forma* assignment. Further, the transaction at issue is presumptively *pro forma* because it fits one of the types described in Note 2 to 63.24(d) of the Commission's rules, 47 C.F.R. §63.24(d). Namely, the "assignment from a corporation to a corporation owned or controlled by the assignor stockholders without substantial change in their interest.

In this case, the assignor, IP NETWORK AMERICA, LLC is a Delaware corporation wholly owned by IP NETWOR AMERICA S.A. de C.V., a Mexican company 99% owned by Rosario Gonzalez Zambrano. The assignee, IBOYLA MEGA DATA, LLC is a Nevada corporation wholly owned by TODO MUNDO FINCHE-PRO S.A.P.I. de C.V., a Mexican company 99% owned by Rosario Gonzalez Zambrano. Therefore, Rosario Gonzalez Zambrano continues to hold ultimate ownership and control of the International Section 214 authorization that is the subject of the present *pro forma* assignment notification.
