The Commission is notified that the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (“Committee”) is returning the above-referenced application to the Commission for further review under the Commission’s rules and regulations.<sup>1</sup>

On January 23, 2021, IP Network America, LLC withdrew its application (File No. ITC-ASG-20181008-00177) for a *pro forma* assignment/transfer of control of its authorization (ITC-214-20130204-00048) to Iboyla Mega Data, LLC.<sup>2</sup> Concurrently with the withdrawal, IP Network America, LLC surrendered its international Section 214 authorizations, FCC File Nos. ITC-214-20130204-00048 and ITC-214-20120427-00112.<sup>3</sup> Accordingly, the Committee is returning the above-referenced application to the Commission.
