Dear Secretary Dortch:

On May 28, 2019, Lingo Management, LLC (“Lingo”) and Fusion Cloud Services, LLC (f/k/a Birch Communications, LLC) (“Fusion”) filed a Notification of Pro Forma Assignment of Customers (“Notification”) to notify the Federal Communications Commission (the “Commission”) of the *pro forma* transfer of certain customers served by Fusion to the operating subsidiaries of Lingo (the “Transaction”).

Pursuant to a request from International Bureau staff, the parties file this supplement to clarify that: (1) the holder of the international Section 214 authorization at issue in the Notification is Fusion Connect, Inc., which holds international Section 214 authority under IB File No. ITC-214-19971001-00592 (IBFS Form Question 5); (2) the name of the Assignor/Transferor for purposes of the Notification is Fusion Cloud Services, LLC (f/k/a Birch Communications, LLC ) (IBFS Form Question 6); and (3) the name of the Assignee/Transferee for purposes of the Notification is Lingo Management, LLC (IBFS Form Question 7). In addition, attached is an updated version of Exhibit 3 to the Notification, which lists the operating subsidiaries of Lingo, the state in which each entity was formed, the states in which the acquired customers are located, and the other states in which the entity offers service.
