Dear Ms. Dortch:

Vector Holdings Group, LLC ("Vector") respectfully submits this supplemental filing to update the record in the above-referenced proceedings, in which Federal Communications Commission Staff are reviewing pending Section 214 transactional applications filed by Vector, TAG Mobile, LLC ("TAG Mobile") and TAG Mobile Bankruptcy Sale Entity, LLC ("TAG Bankruptcy Entity" and, together with Vector and TAG Mobile, the "Applicants").

On September 28, 2020, the Applicants filed a comprehensive application with the California Public Utilities Commission ("CPUC") for approval of the transaction, which will convey the regulated intrastate California operations and assets of TAG Mobile, including its Eligible Telecommunications Carrier designation and related Lifeline operations, to TAG Bankruptcy Entity and transfer control of TAG Bankruptcy Entity to Vector.<sup>1</sup> Consistent with CPUC procedures, notice of the application was published on September 30, 2020, starting the clock on a thirty-day protest period. No protests or other comments on the California application were received prior to the expiration of the protest period on October 30, 2020. The Applicants will file a Joint Prehearing Conference Statement on November 18, 2020 and attend a Prehearing Conference before Administrative Law Judge Daphne Lee on November 23, 2020.
