Assignee: BT Americas Inc. ("BTA" or "Assignee") has not previously received international Section 214 authority in its own name, but is a wholly owned subsidiary of BT Americas Holdings Inc. ("BTAH" or "Licensee"). BTA operates under the international Section 214 authorizations held by BTAH as necessary. BTA and BTAH are Delaware corporations.

Assignor: BT Conferencing Video Inc. ("Assignor") had not previously received authority under its own name, but was wholly owned by BTAH and operated under the international Section 214 authorizations held by BTAH as necessary.

Note that Licensee BT Americas Holdings Inc. will continue to hold all of its international Section 214 authorizations in its own name.

#### **Answer to Question 11**

The following entities directly or indirectly own ten percent or more of the equity of Assignee BTA:

BT United States L.L.C., a limited liability company organized under the laws of the state of Delaware, with offices at 8951 Cypress Waters Blvd., Suite 200, Dallas, TX 75019, whose principal business is Holding Company, directly holds 100% of the equity of BTA.

BT Fifty-Three Limited, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Holding Company, directly holds 100% of the equity of BT United States L.L.C., and therefore indirectly holds 100% of the equity of BTA.

BT Americas Holdings Inc., a Delaware corporation with offices at 8951 Cypress Waters Blvd., Suite 200, Dallas, TX 75019, whose principal business is Holding Company, directly holds 100% of the equity of BT Fifty-Three Limited, and therefore indirectly holds 100% of the equity of BTA.

BT Fifty-One, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Finance, directly holds 100% of the equity of BT Americas Holdings Inc., and therefore indirectly holds 100% of the equity of BTA.

BT (International) Holdings Limited, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Holding Company, directly holds 76 percent of the equity of BT Fifty-One, and therefore indirectly holds 76 percent of the equity of BTA.

BT Holdings Limited, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Holding Company, directly holds 24 percent of BT Fifty-One, and directly holds 100 percent of the equity of BT (International) Holdings Limited, and therefore indirectly holds 100 percent of the equity of BTA.

British Telecommunications plc, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Communications, directly holds 100 percent of the equity of BT Holdings Limited, and therefore indirectly holds 100 percent of the equity of BTA.

BT Group Investments Limited, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose

principal business is Holding Company, directly holds 100 percent of the equity of British Telecommunications plc, and therefore indirectly holds 100 percent of the equity of BTA.

BT Group plc, a company organized under the laws of England and Wales, with a registered office address at 81 Newgate Street, London, EC1A 7AJ, whose principal business is Communications, directly holds 100 percent of the equity of BT Group Investments Limited, and therefore indirectly holds 100 percent of the equity of BTA.

Deutsche Telekom AG, a company organized under the laws of Germany, with an address at Friedrich-Ebert-Allee 140, 53113 Bonn, whose principal business is Communications, indirectly holds 12.06 percent of BT Group plc, and therefore indirectly holds 12.06 percent of BTA.

There are no other individuals or entities that hold ten percent or more of the equity in BTA.

## **Answer to Question 12**

Assignee has interlocking directorates with foreign carriers as listed on Exhibit A hereto.

#### **Answer to Question 13**

Assignor, a wholly owned subsidiary of BTAH, was merged into and subsumed by Assignee BTA, also a wholly owned subsidiary of BTAH, effective September 1, 2020. Assignor's assets and customers were therefore assigned to Assignee in this *pro forma* transaction, and Assignee is successor-in-interest to Assignor. This *pro forma* merger was part of a corporate reorganization designed to simplify the overall organizational structure of various BT entities in the United States.

BTAH will retain all of its international Section 214 authorizations in its own name. This notice is provided to inform the Commission of the assignment of assets resulting from this *pro forma* merger. Note that the licensee name on all of BTAH's international Section 214 authorizations will remain the same.

This assignment is *pro forma* in nature as both Assignor and Assignee were commonly owned by BTAH. Ultimate control and ownership of the authorizations and assets at issue did not change.
