**Answer to Question 13:**

This pro forma assignment took place in connection with a corporate realignment of LKN Communications, Inc. (“LKN”) and its wholly-owned subsidiaries, including ACN Communication Services, LLC (“ACN”). The assignment is pro forma because it assigns the Section 214 authority currently held by ACN, a wholly-owned direct subsidiary limited liability company, to its parent corporation, LKN, with no change in ultimate ownership or ownership interests.
