Specifically, prior to the filing of the Petitions, the Spruce House Partnership LLC held a 25.01% voting interest in GTT, and it will hold the same 25.01% voting interest during the court-supervised restructuring process.

## Answer to Question 13 – Means by Which the Proposed Assignment Will Take Place

On October 31, 2021, GTT and certain of its affiliated debtors, including the GTT Subsidiaries, filed voluntary petitions ("Petitions") for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of New York, commencing prepackaged chapter 11 cases to reorganize under the Bankruptcy Code (the "Chapter 11 Cases").<sup>2</sup> The filing of the Petitions converted the legal status of GTT and the GTT Subsidiaries to debtors-in-possession. The Petitions did not otherwise change the ownership or control of the GTT Subsidiaries.


