NOTIFICATION OF PRO FORMA TRANSACTION

Pursuant to Section 214 of the Communications Act of 1934, as amended, and Sections 63.03(d) and 63.24(f) of the Commission's rules, NetFortris Holdings LLC ("**NetFortris Holdings**") notifies the Commission of an internal *pro forma* assignment of a domestic 214 authorization and international 214 authorization from NetFortris Acquisition Co., Inc. ("**NetFortris Acquisition**") to NetFortris License Company, Inc. ("**NetFortris License**"), which occurred on March 28, 2022 (the "**Transaction**"). NetFortris Acquisition and NetFortris License were both controlled by NetFortris Holdings, LLC. These non-substantive internal *pro forma* assignments did not alter NetFortris Holdings' indirect control of such authorizations.

Prior to the Transaction, NetFortris Acquisition held blanket domestic Section 214 operating authority pursuant to Rule 63.01 [47 C.F.R. 63.01]. NetFortris Acquisition held

international Section 214 authority to provide global and/or limited global resale service, File No. ITC-214-20101112-00459.

Prior to the Transaction, NetFortris License did not provide telecommunications service and did not hold any Section 214 authorizations.

Following the Transaction, NetFortris License (FRN: 0032169138) will hold both the assigned domestic 214 authorization and the assigned international Section 214 authority to provide global and/or limited global resale service, File No. ITC-214-20101112-00459, pursuant to this notification.

Answer to Question 13 (a narrative of the means by which the proposed assignment or transfer of control will take place)

Both NetFortris Acquisition and NetFortris License are controlled by NetFortris Holdings.

In connection with a corporate restructuring, on March 28, 2022, NetFortris Holdings caused its subsidiary NetFortris Acquisition to transfer certain assets, including its customers receiving regulated telecommunication services and domestic and international Section 214 authorization, to another subsidiary of NetFortris Holdings, NetFortris License.
