Re: *Pro Forma Notice of Chapter 11 Bankruptcy of U.S. TelePacific Corp. d/b/a TPx Communications; Mpower Communications, Corp. d/b/a TPx Communications; TPx Communications Co.; Arrival Communications, Inc. d/b/a TPx Communications; and DSCI, LLC d/b/a TPx Communications*

Dear Secretary Dortch:

Pursuant to Section 214 of the Communications Act, as Amended, 47 U.S.C. § 214, and Sections 63.03(d)(2) and 63.24(g) of the Commission's rules, 47 C.F.R. §§ 63.03(d)(2), 63.24(g), U.S. TelePacific Corp. d/b/a TPx Communications; Mpower Communications, Corp. d/b/a TPx Communications; TPx Communications Co.; Arrival Communications, Inc. d/b/a TPx Communications; and DSCI, LLC d/b/a TPx Communications (collectively, "TPx") hereby provide notice to the Federal Communications Commission ("FCC" or the "Commission") that they and certain of their affiliates have filed a petitions under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas on June 28, 2026, in Case No. 26-90625 for U.S. TelePacific Corp., Case No. 26-34544 for Mpower Communications, Corp., Case No. 26-34550 for TPx Communications Co., Case No. 26-34549 for Arrival Communications, Inc., and Case No. 26-34547 for DSCI, LLC. The filing of the petitions served to convert the legal status of TPx and its affiliates to debtors-in-possession.

The bankruptcy filing, however, did not result in any change to the current telecommunications services operations of TPx, its address, or the terms and conditions of its service. There is no impact to TPx's telecommunications services customers, and all existing operations will continue without change as a result of the bankruptcy process.

Because the Commission's filing systems do not provide a mechanism for changing a authorization holder's name to reflect its debtor-in-possession status pursuant to the notification process for an involuntary transfer of control under Section 63.24(g) of the Commission's rules,

the instant notification is being submitted as a *pro forma* assignment of TPx's domestic and international Section 214 authorities from the current holders to debtor-in-possession status.
