NOTIFICATION OF *PRO FORMA* ASSIGNMENT OF CUSTOMERS

Matrix Telecom, LLC (“Matrix”) and Lingo Management, LLC (“Lingo”) hereby notify the Federal Communications Commission (“Commission”) of the *pro forma* transfer of customers of certain direct subsidiaries of Lingo (“Lingo Subsidiaries”) to Matrix (“Transaction”).

I. Description of the Parties

Matrix is a Texas limited liability company with principal offices located at 400 E. Las Colinas Blvd., Suite 500, Irving, TX 75039. Matrix is a direct subsidiary of Impact Telecom, LLC and a wholly-owned indirect subsidiary of Lingo and Lingo Communications, LLC. The company provides or is certified to provide competitive local exchange, intrastate toll, intrastate interexchange, interstate interexchange and international services to business and residential customers in 50 states and the District of Columbia.

Lingo, a Georgia limited liability company with principal offices located at 400 E. Las Colinas Blvd., Suite 500, Irving, TX 75039, is a wholly-owned subsidiary of Lingo Communications, LLC, a Georgia limited liability company. Lingo is a holding company and does not provide telecommunications services. The Lingo Subsidiaries, as detailed in Exhibit 1, are wholly-owned direct subsidiaries of Lingo and provide or are certified to provide competitive local exchange, intrastate toll, intrastate interexchange, interstate interexchange and international services to business and residential customers in 50 states and the District of Columbia.

2. Description of the *Pro Forma* Assignment of Customers

As part of an internal corporate reorganization, the customers of the Lingo Subsidiaries are being transferred to their affiliate, Matrix, beginning October 1, 2020. This Transaction is a *pro forma* assignment of customers between affiliates with the same entities holding the controlling interest in both Matrix and the Lingo Subsidiaries. The transition to Matrix, which operates under the assumed name “Lingo”, will be invisible to the customers of the Lingo Subsidiaries as both companies operate under the “Lingo” name. The customers of the Lingo Subsidiaries will not incur any charges or changes in the services that they currently receive and will continue to receive service under the Lingo name.

- Lingo Communications, LLC, a Georgia limited liability company, holds 100% interest in Lingo Management, LLC. The principal office of Lingo Communications, LLC is 5607 Glenridge Drive, NE, Suite 300, Atlanta, GA 30342.
- Garrison LM LLC, a Delaware limited liability company, holds 100% interest in Lingo Communications, LLC. The address for Garrison LM LLC is c/o Garrison Investment Group, 1290 Avenue of the Americas, Suite 924, New York, NY 10104.

Answer to Question 13

The *pro forma* assignment of the customers of the Lingo Subsidiaries to their affiliate, Matrix, is taking place in connection with an internal corporate reorganization. This Transaction involves the transfer of customers only. The Lingo Subsidiaries currently operate under the international Section 214 authorization of their parent, Lingo. This Transaction does not include the transfer of the Commission authority of Lingo. Lingo seeks to retain in its own name its international Section 214 authority, File No. ITC-214-20160630-00180.
