Direct and Indirect Ownership of Assignee

Assignee is owned by two the following two entities: Marseilles Cellular, Inc. and MTCO Corporation.

Marseilles Cellular, Inc. holds a 98 percent membership interest in Assignee. Its business address is 220 North Menard Street, Melamora, IL 61548. It is organized in the United States, and its principal business is telecommunications.

MTCO Corporation owns 100 percent of Marseilles Cellular, Inc., which holds a 98 percent membership interest in Assignee. Its business address is 220 North Menard Street, Melamora, IL 61548. It is organized in the United States, and its principal business is a holding company of telecommunications services.

Rauh Enterprises, L.P. owns 36.53 percent of MTCO Corporation, which holds 100 percent of Marseilles Cellular, Inc., which holds a 98 percent membership interest in Assignee. MTCO Corporation also holds a 2 percent direct membership interest in Assignee. Thus, Rauh Enterprises, L.P. holds a 36.53 percent indirect membership interest in Assignee. Its business address is 220 North Menard Street, Melamora, IL 61548. It is organized in the United States, and its principal business is investments.

MTCO Corporation also holds a 2 percent direct membership interest in Assignee. Thus, Kathleen A. Rauh holds a 31.18 percent indirect membership interest in Assignee. MTCO Corporation also holds a 2 percent direct membership interest in Assignee. Thus, Ann Dickerson holds a 34.22 percent indirect membership interest in Assignee. No other individual or entity holds a 10 percent or greater direct or indirect interest in Assignee.

## **ANSWER TO QUESTION 13**

The assignment of the international Section 214 authorization from Assignor to Assignee is *pro forma* in nature.

No substantive change in control has occurred because of the conversion of IVC 2-I from a partnership to a limited liability company. MTCO Corporation had a 100 percent partnership interest in IVC 2-I and has a 100 percent membership interest in IVC 2-I, LLC. It indirectly holds a 98 percent partnership interest through its interest in Marseilles Cellular, Inc. (which directly holds a 98 percent membership interest in IVC 2-I, LLC) and directly holds a 2 percent membership interest in IVC 2-I, LLC.

Therefore, the transaction is *pro forma* in nature because the licenses continue to remain under the same control both prior to and following consummation of the transaction.
