
Pursuant to 47 C.F.R. § 63.19, Cypress hereby submits this notice of relinquishment of its international Section 214 authorization.

Cypress is a limited liability company organized and existing under the laws of Delaware with its principal place of business located at 75 Erieview Plaza, Suite 400, Cleveland, Ohio 44114. Cypress holds blanket domestic Section 214 authority as well as international Section 214 authority pursuant to FCC File No. ITC-MOD-20051205-00515 to operate as a global or limited global facilities-based and resale carrier.

Cypress no longer needs international Section 214 authorization because changing market conditions require Cypress to wind down its operations nationwide. Cypress has notified all affected customers. A copy of the notification is attached for the Commission's reference.

Dear Cypress Customer:

Cypress Communications Operating Company, LLC ("Cypress") will discontinue all operations effective March 31, 2015 (the "Termination Date"). As of the Termination Date, Cypress will no longer offer phone or data service. This affects all Cypress customers nationwide. We urge you to immediately find an alternative service provider and transfer your services prior to the Termination Date to avoid an interruption in your services. Cypress is here to assist you in any way with your transfer of service. Customers may call (844) 276-2386 toll-free for further assistance.

The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 30 days after the Commission releases public notice of the proposed discontinuance. You may file your comments electronically through the FCC's Electronic Comment Filing System using the docket number established in the Commission's public notice for this proceeding, or you may address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the §63.71 Application of Cypress Communications Operating Company, LLC. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.
