Section 63.71 Application of PLDT (US) Mobility, LLC

PLDT (US) Mobility, LLC ("PLDT Mobility," or the "Company"), applies for authority pursuant to Section 214 of the Communications Act of 1934, as amended ("the Act"), and Section 63.71 of the rules of the Federal Communications Commission ("FCC," or "Commission"), to temporarily suspend its Smart World Mobile ("SWM") service throughout its entire service territory located in California, Hawaii, Nevada, New Jersey, and New York. PLDT Mobility intends to resume SWM service, and continue to offer long distance services to customers throughout its entire service territory in the future.

As required by Section 63.71(a) and (b) of the Commission's rules, PLDT Mobility provides the following information:

Name and Address of Carrier (47 C.F.R. §63.71(a)(1), (b)(2)):

Date of Planned Suspension/Discontinuance (47 C.F.R. §63.71(a)(2), (b)(2)):

PLDT Mobility will suspend service on December 1, 2015.

Points of Geographic Areas of Service Affected (47 C.F.R. §63.71(a)(3), (b)(2)):

As of December 1, 2015, PLDT Mobility's SWM service will be suspended in California, Hawaii, Nevada, New Jersey, and New York.

Brief Description of Type of Service Affected (47 C.F.R. §63.71(a)(4), (b)(2)):

PLDT Mobility's SWM service is a domestic and international prepaid mobile telecommunication services offered via the GSM network that includes various voice, SMS, and Data Services.

Brief Description of the Dates and Methods of Notice to all Affected Customers (47 C.F.R. § 63.71(b)(3)):

PLDT Mobility will suspend its SWM service offering on December 1, 2015. Notice to all affected customers was provided in writing on October 18, 2015, and was posted on the company's website. *See* **Exhibit A** for a copy of the notice.

As required by Section 63.71(a) of the Commission's rules, copies of this application are being sent via first class mail to the public utilities commissions and governors of California, Hawaii, Nevada, New Jersey, and New York, and also to the Special Assistant for Telecommunications to the Secretary of Defense.

Regulatory Classification of Carrier (47 C.F.R. § 63.71(b)(4)):

PLDT Mobility is considered a non-dominant carrier with respect to the suspended SWM service.

Conclusions:

PLDT Mobility is notifying the Commission of its temporary suspension of its SWM service, effective December 1, 2015. Therefore, PLDT Mobility requests expedited review and approval of this application for suspension of its SWM service offering.

The public convenience and necessity has not, nor will not, be adversely affected by the suspension of PLDT Mobility's services because equivalent services are available from other similar service providers. PLDT Mobility respectfully requests that the FCC approve this Section 63.71 application to relinquish its service offerings.

To keep you on our active mailing list, please email us your contact details at customercare@smartworldmobile.com so we can inform you about customer offers and promotions in the future.



PLDT (US) Mobility, LLC ("PLDT Mobility"), a subsidiary of PLDT US Ltd. d/b/a PLDT US ("PLDT US") operates pursuant to its parent company's Section 214 Authority, File No. 214-20010302-00125. This letter is to notify the International Bureau that PLDT Mobility will be temporarily suspending the provisioning of its Smart World Mobile ("SWM") service on December 1, 2015.

Written notice to affected customers of the planned suspension pursuant to 47 C.F.R. § 63.19(a)(1) was provided on October 18, 2015, more than thirty days prior to PLDT Mobility's proposed date of temporary discontinuance of its SWM service, December 1, 2015.
