Pursuant to Section 63.10(c)(3) of the Commission's Rules, 47 C.F.R. § 63.10(c)(3), France Telecom Long Distance USA, LLC d/b/a Orange Carriers USA ("FTLD"), by its undersigned counsel, hereby files its Provision and Maintenance Report Summary covering the period January 1, 2026 through March 31, 2026.

FTLD is regulated as a dominant carrier on the routes between the U.S. and France, Jordan, Mauritius, Poland, Kenya and Romania. See International Authorizations Granted Public Notice, File No. ITC-214-19991215-00784 (Jan. 5, 2000); see also In Re Foreign Carrier Affiliation Notifications, File Nos. FCN-NEW-20031216-00026, FCN-NEW-20080318-00004 and and FCN-NEW-20211029-00014. As a dominant carrier, FTLD is required to file the Section 63.10(c)(3) Report Summary on a quarterly basis.

For the period covered, FTLD hereby reports that it obtained provisioning and maintenance of basic network facilities by Orange S.A., or other foreign carrier affiliates, between the United States and France Route on Apollo South, FLAG South and Dunant for the provision of U.S. services by FTLD. Current FLAG South, Apollo South and Dunant data concerning the average order times, the outages and intervals between fault report and service restoration, and the percentage of peak hour calls that were incomplete, are not available.

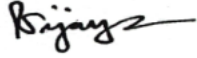
