We hereby submit a request from our client, DirectNet Telecommunications, a Limited Liability Company ("DirectNet"), NDNT Acquisition LLC ("NDNT I"), and NDNT Acquisition II, LLC ("NDNT II", and together with DirectNet and NDNT I, the "Applicants") for special temporary authority, commencing on July 28, 2000, to transfer control from DirectNet to NDNT I and NDNT II of NDNT, Inc.
