**AMENDMENT TO REQUEST FOR SPECIAL TEMPORARY AUTHORITY  
TO CONTINUE OPERATIONS PENDING TRANSFER OF CONTROL APPROVAL**

On July 26, 2005, Guam Wireless Telephone Company, LLC (“Guam Wireless”) filed a Request for Special Temporary Authority to Continue Operations Pending Transfer of Control Approval (“Application”) with the Commission. The Application requested authority to continue operations pending consideration of a transfer of control application filed regarding a transfer control between Fred Liao and Overland Company Inc., transferors, and John K. Wu and the Wu family, transferees (File No. ITC-T/C-20050726-00287). 


