Re: Request for Special Temporary Authority

Dear Sir or Madam:

SatCom Distribution, Inc. ("SatCom") and World Communications Center, Inc. ("WCC") and, together with SatCom, the "Applicants", by their undersigned counsel hereby jointly request the grant of special temporary authority for the transfer of control described in the application filed July 24, 2006, File Number ITC-TC-20060727-00368.

In their application, the Applicants requested authority to transfer control of the Section 214 authorization issued to WCC, ITC-20000803-00478, to SatCom. The Applicants informed the Commission, however, that the transfer of control for which authority was requested had occurred on July 3, 2006, concurrent with the parties' execution of a Stock Purchase Agreement. Consequently, SatCom and WCC respectfully request special temporary authority to permit SatCom, pending action on the parties' application, to retain control of WCC, which has, since July 3, 2006, operated as a subsidiary of SatCom without change in its operations pursuant to its Section 214 authority. The Applicants acknowledge that grant of this request will not prejudice action by the Commission on the underlying application and that any authority granted pursuant to this request is subject to cancellation or modification upon notice, but without a hearing.
