If you haven't already done so, please update IBFS to close out these file numbers (or whatever process there is to remove these file numbers from being "active," thus preventing them from becoming backlogged).

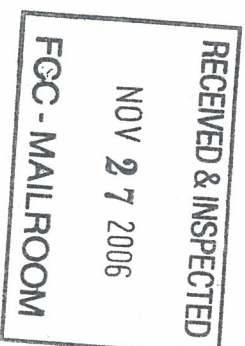



FTMSC US, LLC ("FTMSC"), by its undersigned counsel, hereby cancels, effective October 31, 2006, the following pending Special Temporary Authority Extension Requests: File No. ITC-STA-20060706-00344, filed July 6, 2006 and File No. ITC-STA-200610905-00418, filed September 5, 2006.

These pending extension requests are being cancelled due to the indirect transfer of control of FTMSC from France Télécom S.A. to MobSat S.A.S, effective October 31, 2006.
