Pursuant to Section 1.65 of the Commission's Rules, 47 C.F.R. § 1.65, Stratos Holdings, Inc. ("Stratos Holdings") and Stratos Communications, Inc. ("Stratos Communications") hereby seek to update the above-referenced applications filed by Stratos Communications to reflect a *pro forma* assignment (effective January 1, 2008). Specifically, the International Section 214 authorizations and applications of Stratos Communications have been assigned to Stratos Holdings as part of an internal corporate reorganization. Accordingly, the applicant in the above-referenced applications should be updated to reflect Stratos Holdings, and not Stratos Communications.

The assignment is *pro forma* in nature because both Stratos Communications and Stratos Holdings are controlled by Stratos Global Corporation, a Canadian company that is held in trust and controlled by the Trustee Robert M. Franklin, a Canadian citizen.
