Supplemental Information Regarding Ownership

Dear Ms. Dortch:

Vizada, Inc. ("Vizada") and VIZADA Services LLC ("VIZADA Services" and with Vizada, the "Parties"), by their attorneys and pursuant to Section 1.65 of the Commission's Rules, 47 C.F.R. § 1.65, hereby supplement the record in the above-referenced proceedings to provide additional information regarding ultimate ownership of Vizada and VIZADA Services. Specifically, the Parties provide herein corrected and updated information regarding the ownership of Altamir Amboise SCA ("Altamir Amboise"), which holds an interest in the Parties' common parent, MobSat Group Holding Sàrl.

Maurice Tchénio and Other APSA Partners: In the Supplemental Petition for Declaratory Ruling filed by Vizada, File No. ISP-PDR-20080501-00011 ("Supplemental Petition"), Vizada stated that the total interest Maurice Tchénio held in Altamir Amboise through intermediate entities and in his own name was 12.62%, but also advised that his interest was expected to increase. Supplemental Petition at 5. The Parties now have updated information regarding Mr. Tchénio's holdings in Altamir Amboise, which total 13.05% as of May 28, 2008 as follows: MMG SAS holds 10.11%; Apax Partners SA ("APSA") holds 0.68%; Apax Partners SNC holds 0.10%; and Maurice Tchénio directly holds 2.16%. In

addition to Mr. Tchénio's direct and indirect holdings, other individual French citizens who are partners of APSA also hold interests in Altamir Amboise totaling 2.42%. As a result, the combined interest in Altamir Amboise held by APSA and its partners is 15.47%.

The Fidelity Funds: In the Supplemental Petition, Vizada noted that according to publicly available information FMR Corp and Fidelity International Limited held a 4.38% interest in Altamir Amboise and Fidelity Investments International held a separate 4.38% interest in Altamir Amboise. Supplemental Petition at 5-6. Upon further review, Vizada has determined that the information regarding these Fidelity holdings was partially incorrect. Specifically, Altamir Amboise has no information to suggest that Fidelity Investments International, which at one time was a shareholder of Altamir Amboise, currently holds any interest in the company. FMR Corp. and Fidelity International Limited advised Altamir Amboise that they together hold a 4.38% interest in the company, but to the knowledge of Altamir Amboise, that is the only interest held by a Fidelity fund in the company.

A combined ownership chart is attached.<sup>1</sup> Please refer any questions regarding this matter to the undersigned.

<sup>1</sup> The chart depicts the Vizada and VIZADA Services ownership chain as including VIZADA AS. As the Parties have advised the Commission, a *pro forma* restructuring that would result in re-insertion of VIZADA AS into their ownership chain is planned. See Letter from Karis A. Hastings, Counsel for VIZADA Services LLC, to Marlene H. Dortch, Secretary, Federal Communications Commission, File Nos. 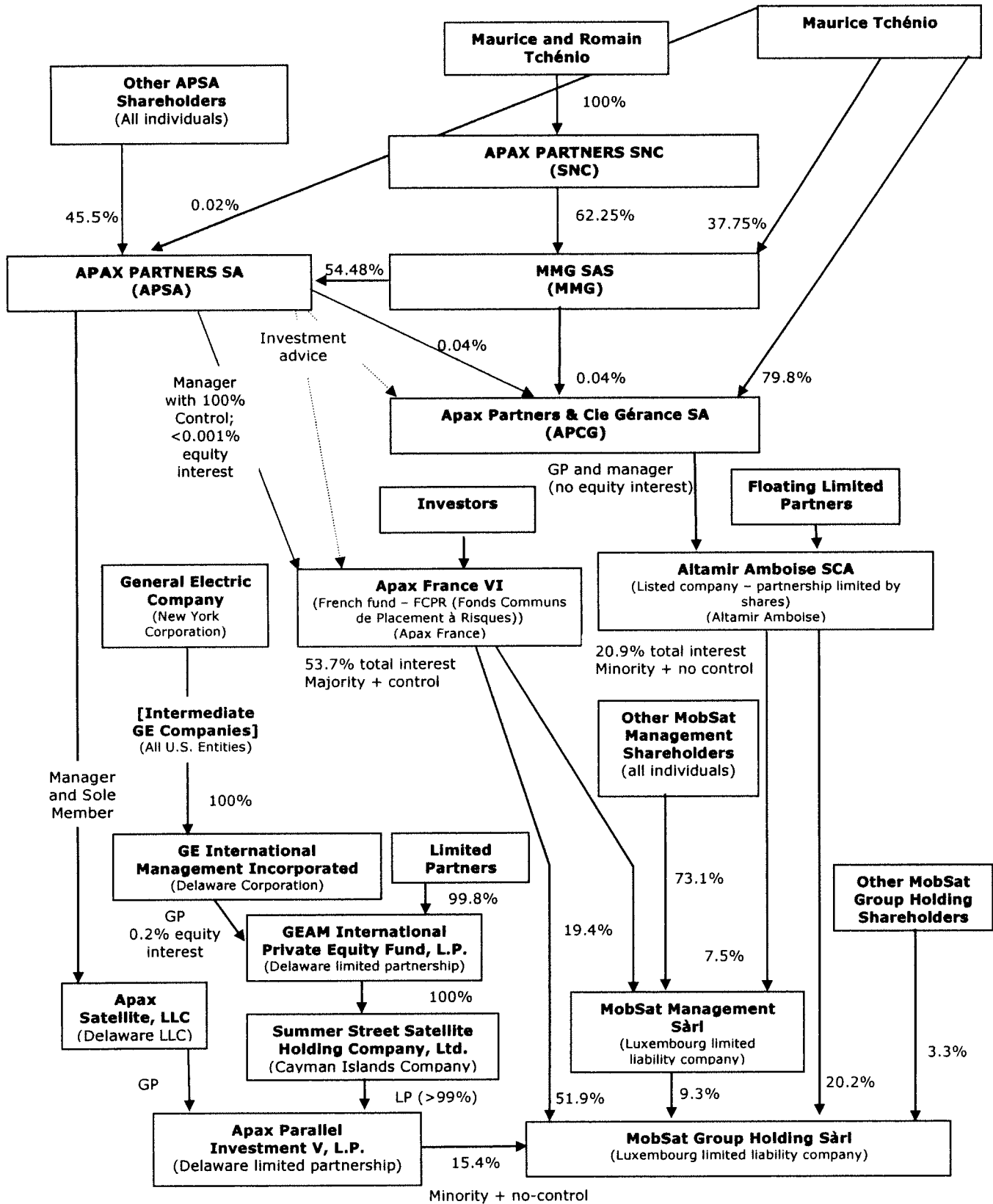
