REQUEST FOR SPECIAL TEMPORARY AUTHORITY

Pursuant to Section 63.25 of the Commission's rules (47 C.F.R. ¶ 63.25), Sky Connect LLC ("Sky Connect" or "Applicant") hereby requests Special Temporary Authority to provide international facilities-based and resold telecommunications services under Sections 63.18(e)(1) and 63.18(e)(2) of the Commission's rules (47 C.F.R. ¶ 63.18(e)(1), 63.18(e)(2)) until the earlier of six months or the date on which the Commission grants Sky Connect permanent international 214 authority to provide such services. An application for such authority was filed with the Commission on October 15, 2008 (FCC File No. ITC-214-20081020-00470).

DESCRIPTION OF THE APPLICANT

Sky Connect, a limited liability company organized under the laws of the State of Maryland, is a wholly owned subsidiary of EMS Technologies, Inc., a publicly traded (NASDAQ:ELMG) corporation organized under the laws of the State of Georgia. The address of EMS Technologies, Inc. is 660 Engineering Drive, Norcross, Georgia 30092. EMS Technologies, Inc., is a leading innovator in the design and manufacture of wireless, satellite and defense solutions, and focuses its unique range of advanced technologies on the needs of broadband and mobile information users. No single individual or entity holds a 10% or greater voting or equity interest in EMS Technologies, Inc.

SUPPORTING INFORMATION

In support of its request for Special Temporary Authority, Sky Connect provides the following information.

Sky Connect has recently discovered that certain services which it began providing in 2003, and which it continues to provide, require such regulatory authority. Sky Connect respectfully states that it was not aware that it required Section 214 operating authority for these services until recently and has attempted to rectify this matter through the submission of this instant application. Sky Connect acknowledges, however, that its provisioning of such services without requisite regulatory authority violates the Commission's rules. Accordingly, for the reasons set forth herein, Sky Connect respectfully submits that mitigating circumstances warrant
