RE: Request for Special Temporary Authority
Liberty-Bell Telecom, LLC

Dear Mr. Krech:

Liberty-Bell Telecom, LLC (“Liberty-Bell Telecom”), pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214, and through undersigned counsel, hereby requests Special Temporary Authority (“STA”) to allow Liberty-Bell Telecom to continue to operate under the corporate ownership structure described below pending Commission action on the Company’s application for permanent authority to transfer control of Liberty-Bell Telecom to Multi-Link Telecom, LLC (“MLT”, now known as Liberty-Bell, LLC).

In 2006, MLT, then a provider of unregulated voice messaging and data storage services, acquired control of Liberty-Bell Telecom. Because MLT was, at that time, an unregulated entity and because Liberty-Bell Telecom was (and remains) a small new entrant carrier, MLT and Liberty-Bell Telecom inadvertently did not identify the requirement that the parties acquire authority from the Commission in conjunction with MLT’s acquisition of Liberty-Bell Telecom. Accordingly, MLT and Liberty-Bell Telecom inadvertently did not seek such approval prior to completing the acquisition.

MLT and Liberty-Bell Telecom emphasize that the transaction was transparent to customers and did not result in any discontinuance or other inconvenience to customers of Liberty-Bell Telecom.

During a recent review of Liberty-Bell Telecom’s records, the company identified the need for Commission approval in conjunction with the acquisition described above. As a result, MLT and Liberty-Bell Telecom have sought formal Commission approval of the transfer of control through an application now pending before the Commission. Through this filing, Liberty-Bell Telecom and MLT seek a grant of special temporary authority to permit continued operations of Liberty-Bell Telecom under the current ownership structure while that application is processed.

Grant of this STA request will serve the public interest, convenience and necessity because such grant will permit Liberty-Bell Telecom to operate under its existing corporate structure in order to continue the provision of regulated service under Liberty-Bell Telecom's existing authority to customers of Liberty-Bell Telecom, all of whom continue to rely on the company for their telecommunications needs. MLT and Liberty-Bell Telecom have sought substantive review of the transaction described above through a formal application with the Bureau. Grant of this STA will ensure that Liberty-Bell Telecom can continue to meet the needs of its customers as that application is considered by the Commission. As Liberty-Bell Telecom is a small, new entrant provider, the application does not raise anti-competitive concerns.

MLT and Liberty-Bell Telecom acknowledge that grant of this STA request will not prejudice any action the Commission may take on the underlying application seeking Commission approval for the transaction described herein. MLT and Liberty-Bell Telecom further acknowledge that grant of this STA may be revoked by the Commission upon its own motion without hearing.




