Dear Mr. Krech:

Liberty-Bell Telecom, LLC ("Liberty-Bell Telecom") and Impact Telecom, Inc. ("ITI", together with Liberty Bell Telecom, the "Parties"), pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214 and through undersigned counsel, hereby requests Special Temporary Authority ("STA") to allow Liberty Bell Telecom to continue to provide international services to certain former customers of ITI pending Commission action on the Company's application for permanent authority to transfer those customers from ITI to Liberty-Bell Telecom.

As set forth in greater detail in the underlying application filed herewith, the Parties have sought approval for Liberty-Bell Telecom to acquire certain assets from ITI. Liberty-Bell Telecom sought and received authority to complete that transaction from the Commission's Wireline Competition Bureau but inadvertently did not identify the requirement that the Parties also acquire authority from the Commission's International Bureau. Liberty-Bell Telecom's international operations were and remain limited, comprising less than 1% of the Company's operations.

During a recent review of Liberty-Bell Telecom's records, the company identified the need for approval from the Commission's International Bureau in conjunction with the acquisition described above. Upon identifying that omission, the Parties promptly sought approval through an application now pending before the Commission. Through this filing, Liberty-Bell Telecom and ITI seek a grant of special temporary authority to permit continued provision of international services to the customers in question while that application is processed.

Grant of this STA request will serve the public interest, convenience and necessity because such grant will permit Liberty-Bell Telecom to continue the provision of regulated service under Liberty-Bell Telecom's existing authority to the affected customers, all of whom

continue to rely on the company for their telecommunications needs. Grant of this STA will ensure that Liberty-Bell Telecom can continue to meet the needs of its customers as that application is considered by the Commission. As the Parties are small, new entrant providers, the application does not raise anti-competitive concerns.

The Parties acknowledge that grant of this STA request will not prejudice any action the Commission may take on the underlying application seeking Commission approval for the transaction described herein. The Parties further acknowledge that grant of this STA may be revoked by the Commission upon its own motion without hearing.
