Liberty-Bell Telecom, LLC ("Liberty-Bell Telecom"), pursuant to Section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. §214, and through undersigned counsel, hereby requests Special Temporary Authority ("STA") to allow Liberty-Bell Telecom to operate pursuant to the corporate ownership structure described in the Amendment being concurrently filed with this Request in IB File No. ITC-214-20080219-00066.

In 2008, Liberty-Bell Telecom sought and received international global resale authority in File No. ITC-214-20080219-00066. During a recent review of Liberty-Bell Telecom's records, the Company identified that the ownership information provided in that Application was inaccurate. Liberty-Bell Telecom has filed concurrently with this Request, an Amendment correcting the ownership information provided in the Application. Liberty-Bell Telecom emphasizes that the error in the original Application was transparent to customers and did not result in any discontinuance or other inconvenience to customers of Liberty-Bell Telecom.

Grant of this STA request will serve the public interest, convenience and necessity because such grant will permit Liberty-Bell Telecom to more expeditiously come into compliance with the FCC's regulations and will correct the Commission's records. Furthermore, grant of this request will ensure that Liberty-Bell Telecom has the authority required to continue the provision of regulated service under Liberty-Bell Telecom's existing authority to customers of Liberty-Bell Telecom, all of whom continue to rely on the company for their telecommunications needs.
