A citizen of the **United Kingdom** owns 16.83% of the transferee. Further, the transferee is 18.77% owned by a **British Virgin Islands** company.

and these applications will be auto-granted on October 25, 2013 per Commission's rules, 47 C.F.R. § 63.12.
