REQUEST FOR EXTENSION OF SPECIAL TEMPORARY AUTHORITY

ATTACHMENT 1

ANSWER TO QUESTION 10

Next Communications, Inc., formerly known as Next Communication, Inc. (“Next Communications”), herein requests a 60-day extension of the Special Temporary Authority (“STA”) previously granted¹ to continue to provide service pursuant to international Section 214 authorization, File No. ITC-214-19990107-00014, pending grant of an application for authority to transfer control of this authorization to Next Communications’ current ownership.²

Grant of this STA extension request is in the public interest because it will allow Next Communications to continue providing service to customers in conformance with the Commission’s rules pending grant of the company’s transfer of control application to update the Commission regarding the company’s current ownership. During the term of the company’s current Special Temporary Authorization, Next Communications continued to work with the Executive Branch Agencies (“Team Telecom”) to answer any additional questions regarding homeland security and law enforcement issues.

Next Communications acknowledges that grant of its request for Special Temporary Authority will not prejudice action by the Commission, or other reviewing agencies, on the underlying Section 214 transfer of control application, File No. ITC-T/C-20120919-00231. Next Communications also acknowledges that any authority granted pursuant to this request is subject to cancellation or modification upon notice, but without a hearing.
