

63.04 and 63.24 of the Commission's Rules, 47 C.F.R. §§ 63.04, 63.24, respectfully request Special Temporary Authority ("STA") to allow ACG to continue to provide service to customers pending Commission approval of the parties' Joint Application for consent to the transfer of control of ACG. ("Transfer of Control Application"). Because ACG is already providing services to international customers, the Applicants respectfully request that the Commission grant this STA request as soon pursuant to Section 214 of the Communications Act, as amended, Asia Consultancy Group, LLC ("ACG") and Mr. Jeffrey Vreeland, (collectively the "Applicants"), as possible. 47 U.S.C. § 214, and Sections

ACG is a holder of an international 214 authorization. Mr. Vreeland, a U.S. citizen, was the former 50 percent owner of ACG. On June 30, 2012, ACG redeemed Mr. Vreeland's 50% interest in the of the transaction, Mr. Sahebzadah has 99 percent equity and voting interest in the Company. The parties have filed an application to approve the transfer of control of ACG from Mr. Vreeland. Mr. Abdul Mohaymen Sahebzadah, a U.S. Citizen, became the 99 percent owner of ACG.
