assignment of STi's international and domestic Section 214 authority to Angel Americas.² an additional period of 14 days, to allow Angel Americas to continue to provide service to the former customers of STi Telecom Inc. ("STi") pending approval of the applications filed for Temporary Authority ("STA") granted September 27, 2013, and extended to April 30, 2014,¹ for Angel Americas LLC ("Angel Americas"), hereby requests an extension of its Special
