On May 21, 2015, pursuant to 47 U.S.C. § 214, SelecTel, Inc. (FRN 0018498352) ("SelecTel"), along with Compass Atlantic Inc. and Compass Capital Incorporated, filed on MyIBFS (Submission ID IB2015000961) its joint request for Special Temporary Authority ("STA") for SelecTel to consummate a pending transaction prior to final FCC approval in order to allow SelecTel to continue to provide service to its end user customers pending Commission approval of their joint section 214 applications for domestic and international transfer of control ("Joint Application").

Attached please find the Certification of the Request for STA to Operate Pending Approval of Transfer of Control Application, as well as a copy of the original Joint Request for STA to Operate Pending Approval of Transfer of Control Application.

A combined Joint Application for approval of the transfer of control was filed on December 12, 2014; however, the international application was withdrawn at SelecTel's request and the domestic application is currently pending before the Commission. A revised section 214 international application has been filed on MyIBFS, Submission ID IB2015000960. A request for an STA is also being sought by separate filing to the Wireline Competition Bureau.

Disconnection of SelecTel's customers is imminent unless it is able to obtain funding which will allow SelecTel to meet critical payment obligations, particularly those to Verizon, which provides underlying network services. If such funding is not provided by May 31, 2015, disconnection of customers will occur.




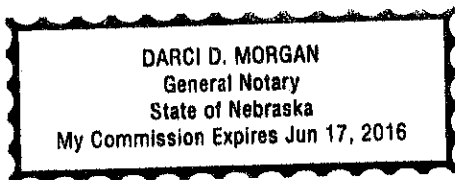

Pursuant to 47 U.S.C. § 214, SelecTel, Inc. (FRN 00184988352) ("SelecTel"), along with Compass Atlantic Inc. and Compass Capital Incorporated, hereby request Special Temporary Authority ("STA") for SelecTel to consummate a pending transaction prior to final FCC approval in order to allow SelecTel to continue to provide service to its end user customers pending Commission approval of their joint section 214 applications for domestic and international transfer of control ("Joint Application").

A combined Joint Application for approval of the transfer of control was filed on December 12, 2014; however, the international application was withdrawn at SelecTel's request and the domestic application is currently pending before the Commission. A revised section 214 international application has been filed on MyIBFS, Submission ID IB2015000960.

SelecTel, Inc. ("SelecTel") provides resold local and long distance voice telephone services in Massachusetts, Minnesota, New Jersey, New York, Oregon, Pennsylvania, and Washington. SelecTel also provides resold wireless services throughout the United States.

Disconnection of SelecTel's customers is imminent unless it is able to obtain funding from Compass which will allow SelecTel to meet critical payment obligations, particularly those to Verizon, which provides underlying network services to both SelecTel's residential landline and individual wireless customers. If such funding is not provided by May 31, 2015, disconnection of customers will occur.

In the meantime, SelecTel and its owners request a grant of Special Temporary Authority to allow SelecTel to consummate the proposed transaction which will allow SelecTel to continue to serve its customers without interruption pending Commission approval of the Joint Application.

SelecTel, Inc., Compass Atlantic Inc. and Compass Capital Incorporated acknowledge that grant of the requested STA will not prejudice any action the Commission may take on the Joint Application and that, once granted, the STA may be revoked on the Commission's own notice, without hearing. SelecTel, Inc., Compass Atlantic Inc. and Compass Capital Incorporated further acknowledge that grant of an STA and the Joint Application will not preclude enforcement action.
