APPLICATION

Pursuant to Section 63.18 of the Commission's Rules, IDT Corporation and InterExchange, Inc. hereby request authority for IDT to acquire control of InterExchange, Inc., which holds international Section 214 authorization to resell the services of other U.S. carriers between the United States and various international points as authorized by the Commission in File No. I-T-C-97-077. Pursuant to an Agreement and Plan of Merger, IDT has entered into a transaction with InterExchange, Inc., pursuant to which InterExchange is expected to become a wholly owned subsidiary of IDT. The closing of the transaction is subject to regulatory approval and the conditions set forth in that Agreement.

This Application is qualified for streamlined processing pursuant to Section 63.12 of the Commission's Rules. Accordingly, we respectfully request streamlined processing of this Application.

- (d) As discussed above, InterExchange, Inc. has previously received authority from the Commission to provide global resale services. IDT has previously received Section 214 Authority to provide various telecommunications services in connection with the broad range of integrated long-distance telephone and Internet access services the Company provides.
- (e) This Application involves the acquisition by IDT of InterExchange, Inc., which previously has been authorized by the Commission to operate as a resale carrier pursuant to the terms and conditions of Section 63.18(e)(2) of the Commission's Rules, including resale of the international services of authorized U.S. common carriers for the provision of international basic switched, private line, data, television and business services to all international points as authorized by the Commission in File No. I-T-C-97-077.

This acquisition of InterExchange, Inc. will serve the public interest and will provide for continuation and expansion of the resale carrier operations provided pursuant to the terms and conditions of Section 63.18(e)(2). Unless otherwise authorized by the Commission, the Company and IDT will continue to comply with all terms and conditions set forth in Section 63.18(e)(2)(ii) of the Commission's Rules as provided for in the authorization.

- (f) Not applicable. This application conforms to the terms and conditions of Section 63.18(e)(2) and is subject to streamlined processing procedures pursuant to Section 63.12.
 - (g) Not applicable, pursuant to Section 63.18(e)(5).
 - (h) (1) InterExchange, Inc. certifies that it is not, and is not affiliated with, a foreign carrier. IDT certifies that it is not, and is not affiliated with, a foreign carrier.
 - (2) The common stock of IDT Corporation is traded on the NASDAQ. Howard S. Jonas, Chairman and Chief Executive Officer of IDT, owns a greater than 10% interest in the Company. As of December 31, 1997, Mr. Jonas owned 36% of IDT's outstanding capital stock in the form of IDT's Class A stock. Each share of Class A stock has three votes per share, such that, as of that date, Mr. Jonas controlled approximately 62.8% of the combined voting power of IDT. Mr. Jonas is a U.S. citizen whose address is: 190 Main Street, Hackensack, New Jersey 07601.
 - (3) This Application does not propose the acquisition of facilities through the resale of the international switched services of another U.S. carrier.

(4) This provision is inapplicable because neither IDT nor InterExchange, Inc. has foreign affiliates within the meaning of the Commission's Rules.

(5) The Applicant will promptly file a corrected certification whenever the substance of any of its certifications, required by paragraphs (h)(3) and (4), is no longer accurate.

(6-8) These subsections are inapplicable because neither IDT nor InterExchange, Inc. is, or is affiliated with, a foreign carrier.

(i) IDT certifies that it has not agreed to accept special concessions directly or indirectly from any foreign carrier or administration with respect to traffic or revenue flows between the U.S. and any foreign country which the applicant may serve under the authority granted under this application, and that it will not enter into such agreements in the future.

(j) In accordance with Sections 1.2001-1.2003 of the Commission's Rules, 47 C.F.R. §§ 1.2001-1.2003, the undersigned hereby certify that neither Applicant nor any party to this application is subject to a denial of Federal benefits that includes FCC benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988. See 21 U.S.C. § 853(a).

WHEREFORE, the public interest, convenience and necessity will be served by a grant of this application pursuant to Section 63.12 of the Commission's Rules.
