SL Participacoes, which owns 10 percent of the equity of AT&T Latin America Corp., is wholly owned by the professional staff of its affiliate, Promon Tecnologia S.A. The largest individual shareholder is Mr. Carlos M. Siffer, a citizen of Brazil, who holds an interest of 5.01 percent. Over 98 percent of the shares of SL Participacoes are held by citizens of Brazil, and the remaining shares are held by citizens of other countries.
