Dear Ms. Salas:

Cash Back Rebates LD.com, Inc. (f/k/a Common Concerns, Inc., and hereinafter referred to as "Cash Back"), by its attorney, and pursuant to Section 63.18(e)(3) of the Commission's Rules, hereby notifies the Commission that it has consummated the transfer of control that was approved by the Commission in ITC-T/C-20000516-00308.

Specifically, Cash Back was authorized by the Commission for the resale of public switched service in ITC-96-180, and recently received approval from the Commission for a transfer of control to Voice & Data Communications (Latin America), Inc. ("VDC Latin America"), effective June 16, 2000 (see FCC Public Notice, DA No. 00-1408, Report No. Tel. 00249, rel. June 23, 2000). The transfer of control has now been consummated.

In addition, pursuant to 63.21(a) of the Commission's Rules, Cash Back submits this informational filing regarding the name change of Cash Back's ultimate parent company. Specifically, Cash Back's ultimate parent company has changed its name from VDC Latin America to Rare Telephony, Inc. ("Rare Telephony").
