Relinquishment of International Section 214 Authority


Dear Ms. Dortch:

WestCom Corporation ("WestCom"), on behalf of Corporate Networks International, Inc. ("CNI"), a wholly owned subsidiary of WestCom, hereby relinquishes effective immediately its authority pursuant to Section 214 to provide international telecommunications services. The file number is ITC-T/C-20001226-00759.

In 2001 the Commission approved the transfer of control of the 214 license from CNI to WestCom in connection with the acquisition of CNI by WestCom. See FCC Public Notice, DA No. 01-176 (Jan. 25, 2001). By this letter, WestCom surrenders the Section 214 license because WestCom does not provide any services for which such license is needed. Therefore, there are no "affected customers" within the meaning of the Commission's international discontinuance rule, 47 C.F.R. § 63.19(a).


