APPLICATION FOR TRANSFER OF CONTROL

New Global Telecom ("NGT"), the shareholder of Single Billing Services, Inc., d/b/a Asian American Association, d/b/a Fiesta Tel¹ ("SBS"), Transferor, and EAAA, Inc. ("EAAA"), Transferee, hereby jointly request authority, pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. Sec. 214 (the "act"), and Section 63.18(e)(5) of the Commission's rules, 47 C.F.R. Sec.63.18(e)(5), to transfer control of Single Billing Services, Inc. d/b/a Asian American Association d/b/a Fiesta Tel, from its current shareholder, NGT to EAAA.

1. Introduction.

By this application, authority is sought pursuant to Section 63.18(e)(5) of the Commission's rules for EAAA to acquire 100% of the issued and outstanding capital stock of Single Billing Services, Inc., d/b/a Asian American Association, d/b/a Fiesta Tel, from its existing shareholder.

There will be no change in the name of the entity providing international resale services Single Billing Services, Inc., d/b/a Asian American Association, d/b/a Fiesta Tel, or in the rates or services offered as a result of this transaction, although various changes may be effected in the future.

¹On October 18, 2000 the FCC authorized the use of the name Fiesta Tel, in addition to the Corporate name and assumed name Asian American Association.




