Western Long Distance, Inc., d/b/a Whidbey Long Distance,
d/b/a Point Roberts Long Distance and d/b/a Hat Island Long
Distance ("Western" or "Applicant") requests Commission consent,
pursuant to Section 214 of the Communications Act and Section
63.18 of the Commission's Rules, to the involuntary transfer of
control of its existing Streamlined International Section 214
Authorization (File No. ITC-214-20000315-00172, granted April 19,
2000) from David C. Henny to Marion F. Henny, his widow, in her
capacity as personal representative of the estate of David C.
Henny.

Grant of this application will serve the public interest,
convenience and necessity because it will allow Western to
continue offering international switched services to existing and
prospective customers while Mr. Henny's estate is being settled.

Western will: (1) maintain separate books of account from WTC and HITC, its affiliated local exchange carriers; (2) not jointly own transmission or switching facilities with WTC or HITC; and (3) take any tariffed services from WTC or HITC pursuant to the terms and conditions of their generally applicable tariffs.

Western will be treated as a nonregulated affiliate of WTC and HITC for purposes of local exchange carrier accounting under the Commission's joint cost and affiliate transactions rules as set forth in Parts 32 and 64 of the Commission's Rules.

¹ Other than such rights, if any, as Marion F. Henny may have under the community property laws of the State of Washington, her ownership interest in, and voting control over, the stock of Whidbey Telephone Company arises from her capacity as personal representative of the estate of David C. Henny.

Foreign Concessions and Arrangements

Western hereby certifies that it has not agreed to accept special concessions, directly or indirectly, from any foreign carrier or foreign administration with respect to traffic and revenue flows between the United States and any foreign country which the Applicant may serve under the authority sought; and that it will not enter into such agreements in the future.

Anti-Drug Abuse Act Certification

Western and Marion F. Henny certify that, to the best of their knowledge and belief, no party to the application is subject to denial of federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. 862.

CONCLUSION

In light of the foregoing, Western respectfully submits that the public interest, convenience and necessity would be served by a grant of the Commission's consent to the involuntary transfer of control of its existing Streamlined International Section 214 Authorization (File No. ITC-214-20000315-00172, granted April 19, 2000) from David C. capacity as personal representative of the estate of David C. Henny.
