Dear Ms. Dortch:

Velocita Wireless Holding Corp. (formerly Interactive Acquisition Inc.) ("VWHC")¹ hereby responds to informal inquiries raised by Commission Staff in connection with the above-captioned filing. In connection with those inquiries, VWHC states, to the best of its information and belief, as follows:

- 1) **No Current Offering of International Section 214 Service:** VWHC confirms that neither it nor Velocita Wireless, L.P. ("Velocita") (formerly Cingular Interactive, L.P.)² is currently offering international telecommunications services pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act"). VWHC further confirms that Commission approval of the transfer of control of Machine License Holding, LLC ("MLH") from Cingular Wireless LLC ("Cingular") to VWHC is a pre-condition to either Velocita's or VWHC's provision of international telecommunications service.



- 2) **Pro Forma Assignment of International Section 214 Authority:** VWHC acknowledges that, pursuant to Commission rules, an authorized international carrier may provide service either directly or through any wholly owned direct or indirect subsidiaries. See 47 C.F.R. § 63.21(h). VWHC confirms that, to the extent necessary, it will cause MLH to complete a *pro forma* assignment of its international Section 214 authority prior to initiating international telecommunications service to ensure compliance with Section 63.21(h).

- 3) **Effectuating the Transfer of Control of MLH:** VWHC confirms that to effectuate the transfer of control of MLH, VWHC will purchase MLH's membership interests. Once this occurs, MLH will be a subsidiary of VWHC and a sister company to Velocita.
