Singapore Technologies Telemedia Pte Ltd ("ST Telemedia"), through its subsidiary, holds a 61.5% equity and voting interest in Global Crossing. In connection with an internal restructuring that was completed on December 31, 2004, the shares of ST Telemedia previously owned by its direct parent company, Singapore Technologies Pte Ltd ("STPL"), were transferred to Temasek Holdings (Private) Limited ("Temasek") with effect from December 31, 2004. STPL is wholly-owned by Temasek. As a result of this restructuring transaction, Temasek now directly owns 100% of ST Telemedia.

This transaction resulted in a transfer of control to a corporation from its wholly-owned direct subsidiary, and thus, qualifies as a *pro forma* transfer of control, as defined in Section 63.24(d) of the Commission's rules. Pursuant to Section 63.24(f)(2)(ii), the undersigned hereby certifies that the foregoing *pro forma* transfer of control, together with all previous *pro forma* transactions, does not result in a change to the actual controlling party.

In addition, pursuant to Section 63.24(f)(2)(i) of the Commission's rules, the applicant provides the following information for Temasek, the transferee:
