In addition, in response to an inquiry of the Susan O'Connell from the FCC's International Bureau, Applicants confirm that the equity interest described within the application corresponds with the voting interest percentages. Therefore, after the closing of the Transaction, there are no entities that were not disclosed with the application or the subsequent supplements that hold a 10% or greater voting interest in A.R.C. Networks, Inc. Note that the ownership interest in A.R.C. Networks, Inc. and Infohighway Communications Corporation will change upon closing of the transaction to the interest described in the initial application filed with the FCC.
