Dear Ms. Dortch:

Maskina Communications, Inc. ("Maskina Communications" or "Company"), pursuant to Section 214 of the Communications Act of 1934, as amended, hereby supplements its Domestic Application to Transfer Consent of a Domestic Carrier dated October 24, 2005 ("Application") with certain information requested by FCC staff. Maskina Communications hereby supplements its application to add the following information:

1. Prior to the December 2, 2004 transfer of control, Transcom Communications, Inc. provided essentially the same type of telecommunications services as is currently provided by Maskina Communications. Namely, Transcom Communications, Inc. provided wholesale interexchange service throughout the U.S. provided through resale agreements with underlying facilities-based carriers and through switching equipment owned, at the time, by Transcom Communications, Inc. The only distinction is that, prior to the time of the December 2, 2004, Transcom Communications, Inc. provided interexchange service through individualized contracts to a handful of large corporate end users. Since the December 2, 2004 acquisition, Maskina Communications has reduced the focus on this aspect of the company's business until, currently, no U.S. domestic service is provided directly to end users.
2. Immediately prior to the December 2, 2004 transfer of control, Transcom Communications, Inc. was wholly owned by Transcom Holdings, LLC. In turn, Scott Bridwell<sup>1</sup> held a 35.52% interest in Transcom Holdings, LLC. No other individual or entity held more than a 10% interest in Transcom Holdings, LLC immediately prior to the December 2, 2004 transfer of control.
3. Immediately prior to the December 2, 2004 transfer of control, the ten percent or greater shareholders of Maskina AS was identical to the ten percent or greater shareholders of Maskina

AS immediately after the December 2, 2004 transfer of control as identified in the Application. Those interests were Transcom Holdings, LLC (16.97%), Kjetil Bohn (12.93%), and Jan Christian Berger (13.54%). Ownership in Maskina AS was not impacted by the Transcom Communications, Inc. acquisition.
