Maskina Communications, Inc. ("Maskina Communications" or "Company"), through its undersigned attorneys, hereby notifies the Commission of the name change of "Maskina AS" to "Vyke AS" with regard to the Company's above-referenced Applications for Consent to Transfer Control of Maskina Communications, Inc.

I. Background

Maskina Communications filed an International Application (ITC-T/C-20050621-00232) on May 31, 2005 regarding the transfer of control of Maskina Communications from Transcom Holdings, LLC to Maskina AS, which had occurred on December 2, 2004. An Amendment to the Application was filed on September 26, 2005 in response to questions from the Commission by letter dated September 16, 2005. The Company subsequently filed the International Pro Forma Transfer of Control Notification of Maskina Communications, Inc. (ITC-T/C-20051006-00397) on October 6, 2005 relating to the June 27, 2005 Tower PLC acquisition of a 100% direct ownership interest in Maskina AS. The filing was pro forma because the same group of shareholders that held a controlling interest in Maskina AS before the transaction held a controlling interest in Tower PLC after the transaction. The Company also filed a Domestic Application for Consent to Transfer Control of a Domestic Carrier (WC 05-299) addressing both the substantial and pro forma transfers of control on October 19, 2005. The Company was granted an extension of its domestic STA on August 11, 2006 for 180 days and its international STA expires on October 2, 2006.

Maskina Communications responded to initial questions from the Department of Homeland Security ("DHS") on October 3, 2005 and has continued to work diligently to respond to all additional questions posed by DHS since that time. Since February, 2006 the Company has been working with DHS on a proposed assurances letter that, if approved, would permit DHS to release the applications back to the Commission for final action. The Company and DHS are now approaching the end of that process and expect to execute that letter shortly.

II. Name Change

On November 1, 2005, after the applications discussed above were filed, the shareholders of Maskina AS changed the company's name to Vyke AS. The change was registered with the Norwegian Register of Business Enterprises on December 14, 2005. This change was a name change only and there was no corporate restructuring or reorganization of the company. There has been no change in the name or ownership of the licensee, Maskina Communications.

The record was not updated with this name change in November, 2005 because Maskina Communications was not aware that such a minor change could potentially impact the applications, or that the Commission should be notified to update the record. The Company had been advised to make counsel aware of any stock sales or corporate restructurings that could involve a transfer of control or otherwise require disclosure to the Commission. However, the Company did not view the mere name change as satisfying these criteria. As the Company has been recently coordinating with counsel to complete the proposed assurances letter with DHS, the fact of the name change was made known to counsel. While counsel believes that this mere name change does not constitute a transfer of control pursuant to the Commission's rules, we wish to notify the Commission to update the record regarding the name change.

The name change of "Maskina AS" to "Vyke AS" changes the name of the transferee in the December 2, 2004 substantial transfer of control to "Vyke AS" and the name of the transferor in the June 27, 2005 pro forma transfer of control to "Vyke AS". Maskina Communications requests that the Commission replace "Maskina AS" with the updated name "Vyke AS f/k/a Maskina AS" in any action taken regarding the applications.
