September 6, 2006**, because we are prepared to take action on these applications. **Electronic filed (e-file) applications are able to be viewed by accessing www.fcc.gov/ibfs and searching by the file number.**

ITC-T/C-20060727-00368 (e-file)

Application for consent to transfer control of the section 214 authorization, ITC-214-20000803-00478, from World Communication Center, Inc. (WCC) to SatCom Distribution, Inc. (SatCom). SatCom is a wholly owned subsidiary of SatCom Distribution, Ltd., which in turn is a wholly owned subsidiary of SatCom Group Holdings plc, a public company based in the **United Kingdom**. Four citizens of the **United Kingdom**, one of whom owns 31% and the other three owns 21% each of the SatCom Group Holdings.

In the underlying application, the Applicants stated that the transfer of control for which authority was requested had occurred on July 3, 2006 without Commission's prior approval. On August 14, 2006 applicants filed an application for a special temporary authority (STA) to permit SatCom, pending action on the parties' application, to retain control of WCC. Applicants acknowledge that grant of STA will not prejudice action by the Commission on the underlying application and that STA is subject to cancellation or modification upon notice, but without a hearing. Therefore, we granted the STA (ITC-STA-20060814-00393) on August 18, 2006.

ITC-214-20060815-00390 (e-file)

Broadband System Group, Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Two citizens of **Venezuela**, each owns 50% of the applicant.

ITC-214-20060815-00392 (e-file)

Broadband Solution Communications Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. A citizen of **Nicaragua** owns 40% of the applicant, and two citizens of the **Dominican Republic**, each owns 40% and 20% of the applicant, respectively.

ITC-214-20060816-00394 (e-file)

Miron Enterprises, LLC's application for authority to provide global resale services between the United States and permissible international points. Applicant is fully owned by a citizen of **Romania** with permanent residence in Canada.

ITC-214-20060816-00398 (e-file)

Color Phone, Inc.'s application for authority to provide global facilities-based and resale services between the United States and permissible international points. Applicant is 100% owned by a citizen of the **Dominican Republic**.

ISP-PDR-20060815-00011 (e-file)

RigNet SatCom, Inc. (RigNet) requests a declaratory ruling, pursuant to section 310(b)(4) of the Communications Act of 1934, as amended, that it is in the public interest to permit an indirect foreign ownership interest of approximately 49% in RigNet, all of which comes from **Norwegian** individuals or companies. RigNet also requests advance authority to accept up to and including an additional aggregate 25 percent total indirect equity and voting interest from any of RigNet's current direct and indirect foreign investors, as well as any other foreign investors without seeking prior Commission approval under section 310(b)(4) of the Act, so long as any additional foreign ownership above 49% does not result in a transfer of control or cause the amount attributable to a single entity from a WTO Member country, or cumulatively to entities from non-WTO Member countries, to exceed 25 percent of RigNet's total ownership. Moreover, RigNet seeks authority to accept additional non-controlling investment by Energivest AS up to any amount less than 50%

RigNet is an applicant for a common carrier VSAT license, File No. SES-LIC-20060815-01373. RigNet is 100% owned by RigNet Inc., a privately held corporation organized under the laws of the state of Texas. RigNet Inc. is a U.S. carrier that holds international section 214 authorization to provide global facilities-based and resale services. RigNet Inc. in turn is owned by a number of individuals and investment funds. The total foreign ownership of RigNet Inc. is approximately 49%, all of which comes from **Norwegian** individuals or companies.

Energivest AS is a sector-oriented investment company organized under the laws of Norway as an "aksjeselskap," comparable in the U.S. to a stock corporation with limited liability. The largest investor in Energivest is Argentum Fondsinvesteringer AS ("Argentum") which has a 29.42% direct and indirect interest. Therefore, Argentum would have an indirect interest in RigNet of approximately 10.9%. **Argentum is a Norwegian government-owned investment company.**

If we do not hear from you by **C.O.B. September 6, 2006**, we will assume that you do not have any concerns with these applications.
