Following up on my voice message regarding the above application. In viewing the attaching IB Report summary for this application and the on-line application, it appears that the transferor and transferee information were inadvertently reversed. This is an **Application of DSL.net, Inc. for transfer of control of DSLnet Communications, LLC (DSLnet) to MDS Acquisition, Inc. (MDSAI).**

The parties are:

Applicant = DSLnet Communications, LLC
Transferor = DSL.net, Inc.
Transferee = MDS Acquisition, Inc.

But when you look at the online form Items 6 and 7 the Transferor is listed as Leah Pahler d/b/a MDS Acquisition, Inc. and the Transferee is listed as DSL.net, Inc. Leah Pahler is the contact for MDS Acquisition but not the transferee and therefore the Leah Pahler d/b/a MDS Acquisition is also incorrect.

I am also sending this to Adrienne and Mikelle in the event that that can provide assistance and information on what needs to be done to correct this.
