Yak America Inc. (formerly Yak Communications (America) Inc.) ("Yak America"), Yaktastic Inc. ("Yaktastic"), and Blackbird Corporation ("Blackbird")(collectively the "Parties"), by their undersigned counsel and pursuant to Section 63.24(e)(4) of the Rules of the Federal Communications Commission ("Commission"), 47 C.F.R. § 63.24(e)(4), hereby notify the Commission that the transaction contemplated in the above-referenced application was consummated on January 16, 2007.¹ This transaction involved the transfer of control of Yak America, a carrier authorized to provide international services pursuant to FCC File No. ITC-214-20010508-00303.
