On December 08, 2006, Arrival Communications, Inc. ("Arrival") and U.S. TelePacific Corp. ("TelePacific") (together, the "Applicants"), filed an application, requesting authority to transfer control of Arrival to TelePacific. Arrival holds domestic and international section 214 authorizations.

TelePacific, a California corporation, is a wholly owned subsidiary of U.S. TelePacific Holdings Corp. ("Holdings"), a Delaware corporation that is a holding company. The following entities own or control a 10% or greater interest in Holdings: Investcorp S.A., a Luxembourg investment company (42%); and Clarity Partners, L.P., a U.S. investment company (22.75%).
